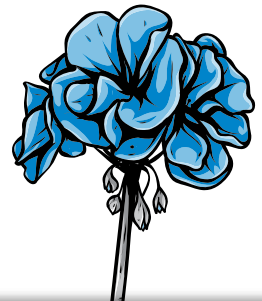
WORK BEGINS ON SAFETY IMPROVEMENTS FOR ROUTE 97 BETWEEN JACKSON STATION AND MARSH ROAD

In mid-April, work began on Route 97 that will focus on a one-half mile long section from the intersection with Jackson Station Road to the end of the curve north of Marsh Road. The area has become known over the years as a very dangerous curve, and the site of many traffic accidents and even fatalities. The work will consist of milling and paving, with a high-friction epoxy surface overlay applied on the curve, and will also include tree trimming, tree removal, permanent signing and pavement markings.

These improvements are a direct result of the hard work and dedicated efforts (on local, state and federal government levels) of the loving family of Cole Patrick McMahon who tragically lost his life on this stretch of Route 97 in 2006. Dolly, Malachy and Logan McMahon should be very proud of the improvements now being made. Once the work has been completed, they will truly have honored Cole's memory by making every motorist on this stretch of road safer in the future. Improvements should be completed by the beginning of June.

THANKS FOR MAKING US LOOK GOOD

A heartfelt thank you goes out to Bob and Janet Mitchell for donating the beautiful red geraniums that brightened up our new municipal building last summer. 2014 Dog License Overdue

Starting on December 1, owners may purchase dog licenses for the following year. All dogs must be licensed by January 1. The license is good for the calendar year, not for one year from date of purchase.

All dogs three months of age or older must be licensed. It is not too late to obtain a license. A regular or senior one year license may be purchased by Summit Residents at the Township building. Life time licenses must be purchased at the County Treasurer's office in the Erie County Courthouse.

The minimum fine for an unlicensed dog is \$50.00 plus costs; the maximum fine is \$300.00 plus costs. Besides licensing, Pennsylvania's Dog Law requires:

- Owners of dogs and cats 3 months of age or older are required to have a current rabies vaccination.
- All dogs must be under control and must not be allowed to run at large. Dogs are personal property, and owners are responsible for damages caused by their dog.
- It is illegal to mistreat or abuse any animal. Violations should be reported to a local humane organization or the police.
- It is illegal to abandon or attempt to abandon any dog.
- No dog under eight weeks of age may be sold, traded, bartered or transferred.
- You may not place any poison or harmful substance in any place where dogs may easily eat it, whether it is your own property or elsewhere.
- It is illegal to interfere with an officer or employee of the Pennsylvania Department of Agriculture engaged in enforcement of dog laws.

In addition to enforcing licensing, the Dog Law Enforcement Office is charged with the following responsibilities:

- Enforcing kennel licensing and inspections
- Investigating dog bites
- Seizing and detaining any dog seen running at large
- Reimbursing individuals for dog-caused damage to livestock, poultry and domestic game birds
- Establishing and enforcing the quarantine of dogs in certain areas when required
- Funding counties and humane organizations to establish dog control facilities
- Providing educational services concerning dog ownership in Pennsylvania
- Enforcing the Pennsylvania Rabies Law

SPRING CLEAN-UP AND ELECTRONICS RECYCLING 2014

FOR SUMMIT TOWNSHIP RESIDENTS ONLY!

Spring clean up will be handled as a **DROP-OFF PROGRAM** again this year. Township crews will only pick-up appliances containing freon (i.e. refrigerators, freezers, air conditioners and dehumidifiers) for residents who have registered and paid for the freon removal in advance (**No later than May 14th**). Residents may bring all other eligible items to the Township garage during the time period detailed below. Township personnel will be on hand to accept items, which must be generated solely from your household and not brought in from elsewhere.

All residents will be required to show proof of residency (photo driver's license).

GENERAL INFORMATION

Please read this information carefully! Only those items listed will be accepted, all others will be turned away.

ALLOWABLE ITEMS FOR THIS YEAR'S COLLECTION

- Air Conditioners (required freon removal fee paid**)
- Appliances – Limited to **two** appliances per household. Duplicates of same appliance not accepted (i.e. two dryers). Refrigerators/Freezers (doors removed and required Freon removal fee paid**)
- Dehumidifiers (required Freon removal fee paid**)
- Washers (clothes and dish), Dryers, Stoves, Hot Water Tanks
- Auto Parts (**NO GAS TANKS**)
- Demolition Waste – bathtubs, sinks, toilets, house doors and windows **ONLY** (no other building demolition waste such as shingles, wood or blocks will be accepted)
- Electronics – TVs, computers, keyboards, monitors, etc.
- Furniture – TV's, mattresses, mattress springs, couch, chairs, dressers, tables
- Lawn Mowers/Roto-tillers/Snowblowers
- Metal Items (unlimited)
- Tires (@ nominal fee – see cost breakdown listed below **) **Limit 12 tires per person.**

ITEMS NOT ALLOWED – THE FOLLOWING ITEMS WILL NOT BE ACCEPTED:

- No Bagged Material - OF ANY KIND
- No Batteries
- No Demolition Waste - other than items specifically listed above
- No Gasoline or Propane Tanks
- No Hazardous Waste – OF ANY KIND
- No Household Garbage
- No Paint or Oil Cans
- No Junk Vehicles

If you are unsure about a specific item, please call the Township at 868-9686.

**** FREON REMOVAL FEE @ \$10.00 each (Non-Refundable)** - Appliances that use freon require this fee payment to defray the cost of having Freon removed. **Payment must be made** at the Township Building **by WEDNESDAY, MAY 14th**. Crews will only pick up items with freon if the resident's name/address appears on a pre-paid list. **Freon items must be placed CURBSIDE BY 8 a.m., THURSDAY, MAY 15th and will be picked up either the 15th or 16th.**

**** TIRE FEE – Tires will be accepted during drop-off hours with payment of the nominal per tire fee as follows:**

\$2 – Tire OFF Rim	(18 inch diameter or less)
\$3 – Tire ON Rim	(18 inch diameter or less)
\$5 – Truck Tire	(19 inch diameter or more)

The nominal fee will help defray costs (per ton) associated with recycling of the tires by Waste Management. **(Note: Fee for tires is to be paid at the drop-off site, not in advance)**

VEHICLES

Summit Township **CANNOT** take vehicles as part of spring clean up!

Vehicles that are unregistered/uninspected and visible on your property are in violation of Township Ordinances. Avoid prosecution by having them removed.

KNOW WHEN AND HOW TO BURN BEFORE YOU START A FIRE!

The only items that can be burned are tree limbs, brush, leaves and other NATURAL vegetative matter. All other items such as papers, newspaper, magazines and cardboard must be recycled and cannot (by law) be burned. Everything else that can't be recycled is considered trash and must be disposed of properly. This includes lumber and all other types of building or demolition waste.

If you are burning natural vegetation in a barrel or container, no permit is needed. If you are burning out in the open, A PERMIT MUST BE OBTAINED FROM THE TOWNSHIP PRIOR TO BURNING! There is no fee for this permit. Burning is allowed from 7am to 8pm (except for campfires), and controlled open burning requires a quick phone call (451-7154) to prevent our already overworked Perry Hi-Way volunteers from being called out needlessly. We keep permits on file for easy renewal via phone.

SUPERVISOR'S CORNER

Hello all -

It has been a LONG cold winter and, hopefully will be much warmer and greener soon. The Township crew has been cleaning up roads from snow plowing and patching, where they can, when weather allows. I think we have been very lucky with Summit's roads because they have held up well even with the deep frost this year. Many municipalities are having big trouble because of the frost. Our crew has been replacing and repairing culverts and cleaning ditches. The ball fields are almost ready and so is Picnicana. There always seems to be much cleaning and prep work in early spring. The wet ground doesn't help but seems to be getting better every day.

I am still getting to know all the employees so we can better communicate and work together. Our Township has good people working here and continues to improve with modern technology like Global Information Systems (GIS). This will be used to mark, locate and record all information regarding storm sewers, water lines, etc.

We are planning on doing more storm sewer construction this year; first to complete existing projects and then do more where needed on a priority basis. I like storm sewers because they eliminate ditches and make yards easier to maintain. Just remember, the area continues to be part of the road right-of-way and nothing but grass can be located where the ditch used to be (i.e. no plantings, posts/reflectors, landscaping rocks, etc.) as it still belongs to the Township.

Another observation I have quickly made is that zoning is both complicated and important. There are times when some people do not like zoning but these laws and regulations are for the good of all and help protect all of the Township's citizens. Summit has many homes and businesses; it is not a rural area. Without laws and regulations everyone would live in chaos. Our zoning office does a very good job of explaining ordinances and requirements. Make sure to contact them in the early stages of planning, before construction, to avoid expensive problems when it may be too late. Zoning doesn't make everyone happy but these laws are based on what is good for the majority of our population.

Also, with summer coming, please watch out for motorcycles. They are hard to see sometimes at intersections because of trees and poles. Look twice and save a life.

It's nice to finally see everything greening up, unfortunately, spring often brings with it severe storms and weather events. Even though these tend to be more severe in the southern states, please make sure your family has an emergency plan in place to react quickly if a severe weather or tornado warning is issued. Especially if you have young children! Family members are often scattered – at work, school, home – your children might be with a sitter or participating in an activity if a disaster strikes. You may not be able to communicate with other family members until a period of time AFTER an event so they need to know BEFORE what you want them to do. How well your family is prepared depends solely on YOU!

Supervisor Lee and I recently participated in a two-day intensive disaster training program offered by the Federal Emergency Management Agency (FEMA). FEMA is trying to learn from past experiences and better prepare local officials and emergency management responders for what needs to be done before, during and after any type of disaster. Seeing what is expected at the local level is almost overwhelming (I thought my head was going to explode by the end of our second day). That's why I cannot stress enough the importance of your own family having an emergency plan. Depending on the size of the disaster, emergency responders and local officials may not immediately be available to assist you. Great online resource to help you create your family plan can be found at www.redcross.org (scroll down to bottom and click on 'Prepare Your Home and Family') or www.ready.gov/make-a-kit. If you don't have internet access, stop by the Township office (or call us) and we can provide brochures and other guides to help.

I would like to take this opportunity to sincerely thank our **long-time Emergency Management Coordinator, Bill First, and his awesome volunteers, Darrel and Wanda Rhoades**, for their commitment of time and willingness to take command at the local level should any type of disaster occur right here in Summit Township. These folks truly care about their Summit neighbors and are very much appreciated!!!

SUMMIT TOWNSHIP ART SHOW

Calling all resident artists! Summit Township will also be holding an Art Show as part of the open house to show-off our new municipal building during resident's weekend July 25-27th. The show will be open to students (grades 6-12), pastime and professional artists. You are a **pastime artist** if your art is just for fun and you do not sell your work. You are a **professional artist** if any of the following apply: you've had a show, are a commercial artist, teacher of art, own a gallery and/or have an art degree.



Types of work to be accepted include two dimensional (paintings, oils, watercolors, acrylics, pastels, photography, drawings, graphite, colored pencil, charcoal, etc. We will accept original fine art prints but they must be original prints, no reproductions.) three dimensional (3-D, clay, sculpture, metal and wood) and mixed mediums (works that combine more than one medium in a unique way). No crafts will be accepted. Art cannot be of inappropriate nature at the discretion of the show committee.

Submission Details: No entry fee; Summit Township residents only; up to two (2) entries per artist; must be no more than 30 inches wide (due to space); art must be framed and wired for hanging if you are a pastime or professional artist; student art needs only to be matted; entries can be marked "FS" (for sale) if so desired (an artist's inquiry box will be provided – all sales and any taxes are the responsibility of the artist.)

Entry form only must be **mailed by July 1 and received** (or dropped off) **at the township office no later than July 5, 2014**, so proper space can be allotted.

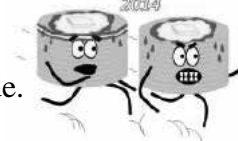

FUND DRIVE 2014 begins May 1, 2014

The annual residential fund drive campaign kicks off May 1, 2014. The fund drive materials were delivered to the post office for mailing on April 30th. We are asking for PARTICIPATION FROM EVERY HOUSEHOLD this year. With the closing of our bingo games we must rely more on the residents to pay for the services we provide. Please read this year's fund drive brochure carefully as it gives a detailed account on where all your donations are spent. It takes over \$250,000 a year to keep the fire and ambulance service open and in operation, and that is with no outstanding debt. We cannot stay in operation as we do now without your financial support.

We ask every household for a donation of just \$50.00 per year. Some residents donate at a higher level and we thank them for their generous support. Please keep in mind, donations of any size are welcomed and will be used to keep our operations running. Watch for your fund drive packet to arrive in your mailbox. If you fail to receive one please call Audrey at the station 864-0680 and let her know you need a fund drive mailer.

BINGO games closed

The board of directors made the decision to close our BINGO games at the January Board Meeting. A review of the financial statements made the decision pretty easy from a business standpoint with a loss of over \$10,000 on Bingo games over the past year. Many changes were tried to make the BINGO games profitable but were never successful. The draw of the gambling dollars by our local casino proved to be stronger than our bingo game. Many of our players had stopped coming to bingo and put their gambling dollars into the slot Machines to attempt to win a much larger progressive jackpot. Those few people that did come to BINGO did not spend the money to purchase the instant tickets or pull tab games like in years past.

The loss of Bingo income will mean more reliance on the funds generated from the Business & residential fund drives. For this simple fact alone we are asking for all households to send in a donation to the annual fund drive campaign.

Perry Hi-Way Hose Company Receives Federal Grant - includes scholarship monies.

The fire department has been able to secure a grant from the federal government through the Staffing for Adequate Fire & Emergency Response (SAFER) grant program. This grant can only be used to help recruit and

retain volunteer fire fighters and EMS personnel. The \$536,000 grant will be released over a 4 year period and has very specific programs where the money can be spent. This grant cannot pay for utility bills, buy new fire trucks or be used to work on the fire stations. The grant will be used to hire a marketing and advertising firm, make a recruitment video and hand out materials to recruit new members. We also have money for a new scholarship program in the amount of \$40,000. This will fund 10 \$4,000 scholarships to attract new members to the department. Members may join the department to do firefighting duties, ambulance duties or both. The majority of our emergency calls are ambulance related. While working my part-time job at Walmart on Peach Street, I went into cardiac arrest. I was sitting down, dizzy and disoriented, and the store assistant manager Adam called 911. Perry Hi-Way Hose Co. responded quickly.

I am told that upon their arrival they loaded me into the ambulance and headed toward the hospital. Apparently as soon as I got into the ambulance, my heart stopped. Quick action by the medics doing CPR shocked my heart back to beating again. From what I am told, they had to shock it five times before it started beating. The next thing I knew I was in the hospital.

The attending doctors and nurses told me that I was in the right place at the right time, as most don't survive a situation like this. Thanks to quick action by Adam, fast response by Perry Hi-Way and proper training for the volunteers, I am still alive today.

Something like this could happen to anyone at any time. I encourage everyone to support their volunteers and their departments. Without proper funds, they cannot get the training one needs to save a life. I personally want to thank Kip Hayford, John Bosley and Scott Galaway. Your training saved my life, and I will never forget it.

FROM YOUR SUMMIT TAX COLLECTOR:

It has been a long, cold winter and I for one am happy that warmer weather while maybe not on our doorstep, is finally in the neighborhood at least!

The 2014 County-Township bills were issued March 1st and are for the calendar year, January 1, 2014 through December 31, 2014. Mills remained the same as last year for the County at 4.93 and for the Township at .59. Discount of 2% ends April 30th; Face ends June 30th and after that 10% Penalty applies. If you did not receive a tax bill, please contact my office.

The 2014/2015 School bills will be issued July 1, 2014 and are for the fiscal year of July 1, 2014 through June 30, 2014. I do not know at this time if the mills will be increased or not. Generally the budget is not finalized and passed until mid or end of June. Discount of 2% ends on August 31st, Face on October 31st and 10% Penalty until the end of the year. Again, if you do not receive a tax bill by the second week of July, please contact my office.

The last day the office will be open before the end of August will be Thursday, August 28th, regular office hours of 10AM-2PM. If you are paying by cash or wish to come into the office to pay, please remember the date. You may use the mailslot at anytime through the 31st. If sending via US mail, postdate MUST be August 31st to be accepted at Discount.

Sanitary Sewer Extension Project 2010: Proctor, Merle, Melvin, Dorn and New Roads

Connection Notices were mailed to the home owners in the Contract #1 project area along Proctor and Merle Avenues and Melvin Road. We had planned to issue the Connection Notices to all three project areas at the same time. However, Contracts #2 and #3 started late due to permitting issues and fell behind due to the exceptionally cold winter. In addition, there were many home owners, in the Contract #1 project area, interested in connecting as soon as possible; therefore, on April 15, 2014 the Summit Township Sewer Authority (STSA) issued the official Connection Notices in the Contract #1 project area.

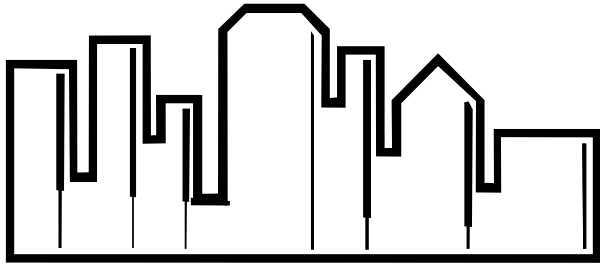
Each home owner received an Assessment of Cost as well as a packet of information showing details on how and where to make a connection. We are pleased to report that the cost per home remains \$7,500 for existing homes. Home owners should share the connection and location details with the plumbing contractor of their choice. We suggest that, when comparing contractors, the home owners get estimates from 2-3 contractors that have done similar work in Summit Township. We also recommend that, prior to starting, the homeowner get a written proposal for the required work. The home owners should complete their connections by July 15, 2014 as they have 90 days to make their connections.

McLallen Excavating will be coordinating the lawn restoration with their landscaping subcontractor once all of their construction work is complete. Please bear in mind, McLallen Excavating is also responsible for the construction on Dorn Road and for the New Road Lift Station. Their contracts should be substantially complete by May 24, 2014. There is nothing we can do about the unsightly excavation in the meantime. Often area contractors can continue to work during the winter months but it does depend on weather conditions. Unfortunately, the work that began last year was interrupted by one of the longest and coldest winters in the last 35 years. Frost was reported at depths of 4 feet, which would have required extraordinary measures of excavation. Those measures are not included in the scope of work in our standard contract because it costs more money. Therefore the work was halted until conditions improved.

Contract #2 - Dorn Road and Contracts #3 - New Road started late in the fall and shut down when the cold temperatures hit the area. We expect the work will resume as the weather permits. Connection notices will be issued in the remaining project areas after the construction work is complete, the pipe and manholes tested and the engineer certifies that the sewers are ready to use. Since the completion dates of Contracts #2 and #3 are unlikely to coincide, we are considering mailing the connection notices as the remaining contracts are finished.

We want to thank the Summit Township Residents in the project areas for their cooperation and support with making this project successful; one that not only improves the area but is economical. We want to welcome those new customers to a new era of service and betterment of their property.

If any sewer customer has any questions or concerns, please feel free to call the Authority at 868-4495 or attend a monthly meeting. Check your Township calendar for Sewer Authority meeting dates, (generally the last Thursday of the month, except November and December are one week earlier). The Authority hours are 8:00 AM - Noon and 12:30 - 4:30 PM, Monday through Friday. If you plan to attend a meeting, please call and let us know.



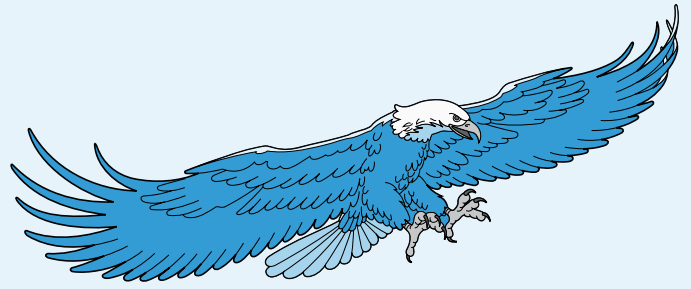
