SUMMIT TOWNSHIP SUPERVISORS October 21, 1996

ORIGINAL

VEHICLES AND TRAFFIC

WHEREAS, the Supervisors of Summit Township have reviewed traffic and engineering studies for the purpose of determining whether parking should be permitted, whether speed limits should be established and whether stop signs should be erected on certain roadways and intersections in the Township; and

WHEREAS, the traffic and engineering studies indicate that for various reasons, as stated therein, establishing a parking prohibition, limiting the speed of vehicles on those roadways studied and erecting stop signs in the intersections studied would be in furtherance of the public health, safety and welfare;

NOW, THEREFORE, the Board of Supervisors of the Township of Summit, Erie County, Pennsylvania hereby ENACTS AND ORDAINS that:

Section 1: No person shall stop, stand or park a vehicle at any time upon any of the roads or parts of roads as follows:

Race Avenue - Route 97 to Johnson Road (both sides)

Oliver Road - Five Points intersection south to Summit Township line (both sides)

Section 2: The speed limit for both directions of traffic along the following roads is hereby established at the rate of speed indicated and it shall be unlawful for any person

to drive a vehicle at a higher speed than the maximum speed prescribed for that road or part of a road:

Donation Road -- entire length of Donation Road within the Township -- 40 mph

Hamot Road -- entire length of Hamot Road within the Township -- 45 mph

Section 3: The following intersection is established as a stop intersection and official stop signs shall be erected or are ratified if previously erected in such position upon the first-named road as to face traffic approaching in the second-named road in the direction or directions indicated. Every driver of a vehicle approaching any such intersection upon the first-named road, in the direction or directions indicated, shall come to a full stop before entering any such intersection.

Jackson Station Road (eastbound) - intersection with Donation Road

Donation Road (southbound) - intersection with Jackson Station Road

Donation Road (northbound) - intersection with Jackson Station Road

Section 4: The speed limits, no parking prohibitions and stop intersections shall be identified by the placement of approved signs within the designated areas for the purpose of notifying all persons.

Section 5: Any person who shall operate, park or stop a motor vehicle in violation of this Ordinance, upon conviction thereof, shall be liable for all fines and penalties imposed by the Pennsylvania Motor Vehicle Code.
