

ORDINANCE NO. 2010-01

SUMMIT TOWNSHIP SUPERVISORS

June 7, 2010

VEHICLES AND TRAFFIC

WHEREAS, the Supervisors of Summit Township, Erie County, PA, have reviewed a traffic and engineering study for the purpose of determining whether parking should be permitted on a certain roadway within the Township; and

WHEREAS, the traffic and engineering study indicate that, for various reasons, as stated therein, establishing a parking prohibition, would be in furtherance of the public health, safety and welfare;

WHEREAS, Summit Township had adopted Ordinance #1989-07 and desires to amend it adding the roadways listed below;

NOW, THEREFORE, the Board of Supervisors of the Township of Summit, Erie County, Pennsylvania, hereby ENACTS AND ORDAINS that:

Section 1: No person shall stop, stand or park a vehicle, at any time, upon any of the roads, or parts of roads, as follows:

Oliver Road (SR 4008) – Robison Road (T-406) to Old Oliver Road (T-300), southerly side

Robison Road (T-406) – The median strip from Oliver Road (SR 4008) to Hessinger Drive (T-415)


Section 2: The no parking prohibitions shall be identified by the placement of approved signs within designated areas for the purpose of notifying all persons.

Section 3: Any person who shall operate, park, or stop a motor vehicle, in violation of this Ordinance, upon conviction thereof, shall be liable for all fines and penalties imposed by the Pennsylvania Motor Vehicle Code.

Supervisor Church acknowledged receipt of HRG's suggestion to amend the specifications. Secretary Yeast confirmed that those changes have been incorporated into the specs.

Motion by Gradler, seconded by Coon, to amend Ordinance #1989-07 adding Oliver Road from Robison Road to Old Oliver Road, southerly side; and Robison Road, the median strip from Oliver Road to Hessinger Drive.

ORDINANCE #2010-01 NO PARKING ON PORTIONS OF OLIVER RD. AND ROBISON RD.

Atty. Sennett explained that the 1989-07 Ordinance details the provisions of the No Parking Ordinance, including towing and storage. Atty. Sennett added that the Board has historically included each roadway on a separate ordinance.

Motion by Gradler, seconded by Coon, to amend the above motion adopting Ordinance #2010-01 describing the above referenced roadways and referencing Ordinance #1989-07.

Supervisor Church expressed concern for establishing standards for soliciting towing companies. After discussion, it was determined that no towing orders will be administered until standards are established for the June 21st Regular Business Meeting.
